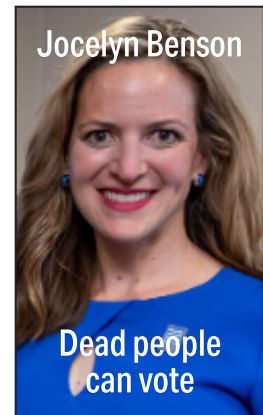
## The Democrats plan to rig and steal the 2024 Election

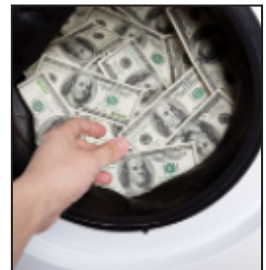
## Democrats use COVID-19 Scare tactics to Create Permanent Voting Advantages
