How Democrats Are Stealing the 2024 Elections and Future Elections With Massive Law-Breaking and “Lawfare”

The Biden Administration and Democrats at every level of government have made it clear they will stop at nothing to win in 2024. And they are engaged right now in massive law-breaking and “lawfare” to do so.

“Lawfare” is a form of warfare. This is when politically motivated prosecutors, lawyers, and judges misuse the law (often twisting and distorting the language of the law) to target and destroy their political opponents to win power . . . and achieve permanent power.

Here are a few examples of how the Biden Administration and Democrats are using “lawfare” to destroy **Donald Trump**, imprison and terrorize his supporters, win the 2024 Elections, and transform America into a permanent one-party socialist dictatorship in which a conservative can never again win a national election.

Political Indictments Against Donald Trump by the Biden Justice Department and Far-Left Democrat Prosecutors.

- On August 8, 2022, the **Biden FBI** raided the home of Donald Trump. This was the first time a U.S. President has used the federal government's law enforcement powers to target a former American President. Donald Trump is also the leading opposition candidate to Biden.
- Democrats are trying to win in 2024 by putting the leading Republican candidate Donald Trump in prison for the rest of his life on bogus charges and by using novel legal theories never attempted before in American history.
- The Biden Justice Department and radical Left local prosecutors appear to have coordinated four separate court cases and have come up with 91 felony counts. Many of these charges center around Donald Trump merely expressing his opinion about the 2024 Election.
- According to *The New York Times*, in a report on April 2, 2022, **Joe Biden** pressured his **Attorney General Merrick Garland** to prosecute his main political opponent, Donald Trump. *The New York Times* reports that Biden repeatedly expressed frustration with Garland on how long it was taking Garland to prosecute Trump.
- Democrats aim to put **Donald Trump** in prison for the rest of his life. This is also intended to send a message to Republicans not to run for elected office, lest you end up in prison. The goal is to terrorize critics of the Democrat Party to remain silent and stay out of politics.
- Even if Democrats fail to put Donald Trump in prison, they still achieve their goal of making it very difficult for **Donald Trump** to campaign while these trials and legal proceedings are

taking place during the 2024 Election Year. And they still strike fear in the hearts of Republicans who will now think twice before running for public office.

- The U.S. Justice Department has a longstanding policy of not indicting leading Presidential candidates during a Presidential Election Year. This was the reason given by FBI Director **James Comey** for not indicting **Hillary Clinton** in 2016 over her storage of top secret classified documents on her home-based server after she left the State Department. Hillary Clinton was never indicted for this, even after the campaign was over. But the Biden Justice Department is prosecuting Donald Trump for similar alleged infractions in the documents case. In violation of law, **Joe Biden** kept and stored classified documents in in garage from his time as Vice President and U.S. Senator. But he is not being prosecuted.
- Without even a trial on the merits, a radical Left local judge in Manhattan named **Arthur Engoron** declared the Trump Organization guilty of fraud, ordered the Trump Organization dissolved, and banned Donald Trump and his family from doing business in New York state. This is clearly unconstitutional. There was no trial on the merits of the case. Judge Engoron simply declared Trump guilty in a summary judgment and went straight to the penalty phase. The hearing on the penalty lasted 10 weeks. Judge Engoron expressed his bias throughout the 10-week penalty phase hearing, often smirking, while his wife was posting anti-Trump material on social media, often including obscenities about Trump in her posts.

Democrats Are Trying to Remove Donald Trump from the 2024 Ballot

- The Colorado Supreme Court has issued an unsigned opinion disqualifying Donald Trump from the ballot in Colorado. The supposed basis for this ruling is the 14th Amendment's prohibition against people holding certain federal offices who have engaged in "insurrection" or "rebellion." Of course, Donald Trump did no such thing. In his speech prior to the January 6th protest at the Capitol, he emphasized "peaceful" protest. Donald Trump has never been charged with "insurrection."
- The Maine Secretary of State, Shenna Bellows, has unilaterally removed Donald Trump from the Republican primary ballot in Maine. She describes herself as a "voting rights activist." She campaigned for same-day voter registration and ranked-choice voting. She had been the Executive Director of Maine's ACLU chapter for 9 years.
- Other states run by Democrats have signaled they plan to follow Colorado's lead and remove Donald Trump from the ballot. Democrats claim they are working to keep Trump off the ballot to "save democracy." For Democrats, "democracy" means you only have a choice to vote for candidates approved by Democrats.

Weaponizing Government Against All Who Disagree with Democrats

- In March of 2022, the FBI rounded up 10 non-violent pro-life activists with SWAT team raids aimed at terrifying and silencing anyone who stands for life. A video of these raids shows armed FBI agents holding pro-lifers at gunpoint, ordering them to drop to their knees, and requiring them to shuffle backwards out the front door in the middle of the night. The pro-lifers cooperated fully. These pro-life activists are being charged under the Freedom of Access to Clinic Entrances Act (FACE).
- So far, the Biden Justice Department has rounded up 26 non-violent pro-life leaders. These pro-life activists were not blocking any entrance to clinics. They were simply providing information on what an abortion is and alternatives to abortion. They also were holding prayer vigils. And they offered financial support for the child should the mother decide not to get an abortion. The Biden Justice

Department is seeking 11-year prison sentences for these non-violent pro-life activists, including for two women in their 70s.

- *Newsweek* reports that Joe Biden's FBI is gearing up to target supporters of **Donald Trump** as "domestic terrorists" during the lead-up to the 2024 Election, stating that: "Testimony from more than a dozen current or former government officials who specialize in terrorism confirmed that this increase in targeting was born out of the FBI's decision to lump Trump supporters into its expanded definition of 'domestic extremism.'"

Unequal Justice

- The Biden Justice Department prosecuted January 6th protesters much more aggressively than the anti-police rioters of 2020. At least 34 Americans lost their lives in these anti-police riots of 2020. More than 2,000 police officers were injured in these anti-police riots. At least 6 police officers were killed. The arsons and vandalism caused more than \$1.2 billion in property damage. A federal court house in Portland was torched along with police stations. No police officers were killed by the January 6th protesters, though some were injured and one died later from natural causes unrelated to the January 6th protests.
- The Biden Justice Department has prosecuted and imprisoned more than 1,200 January 6th protesters, most of them peaceful. Non-violent January 6th protesters received multi-year prison sentences. The so-called "Qanon Shaman" with the Viking hat was sentenced to 41 months in federal prison for simply walking around inside the Capitol. The leader of the Proud Boys was sentenced to 22 years in prison even though he was not present at the January 6th protest.
- For actual insurrectionist language, here is what **Kamala Harris** said in 2020 when she encouraged the anti-police rioters to commit more violence and mayhem:

"But they're not gonna stop. They're not gonna stop, and this is a movement, I'm telling you. They're not gonna stop, and everyone beware, because they're not gonna stop. They're not gonna stop before Election Day in November, and they're not gonna stop after Election Day. Everyone should take note of that, on both levels, that they're not going to let up — and they should not. And we should not."

This amounted to incitement to violence by Harris. Around this time, mobs tried to storm the Trump White House, which required then President Trump to shelter in the White House bunker. The mob torched the historic St. Johns Episcopal Church, which is in view from the White House. A car attempted to crash through a police barricade that was protecting the White House.

All this was reminder of **Adolf Hitler's** Brownshirts who used violence to intimidate his political opposition during Hitler's rise to power. Communists use the same tactics. Democrats are using the Hitler/Communist playbook of intimidation through violence to frighten their critics into silence.

In the tradition of Joseph Stalin, they misuse the criminal justice system to put their critics in prison whenever possible, imposing maximum penalties for trivial infractions, or they just make up crimes.

Biden Illegally Orders Federal Government Agencies to Maximize Voter Turnout in Democrat Areas

Biden has ordered hundreds of federal agencies and departments to interfere in state and local election administration.

Executive Order 14019 requires that all departments use U.S. taxpayer money to boost voter registration and get-out-the-vote activities in predominantly Democrat areas. This is a violation of the Hatch Act and other federal laws. To fulfill this order, federal agencies and departments are working with and funding radical Left non-profit organizations to “register and turn out voters.”

Biden Administration Wages Lawfare to Overturn Election Integrity Laws in Key Battleground States

- In states such as Georgia, where Democrats don't hold political power, Biden's Department of Justice and leftist legal organizations have launched dishonest lawsuits to overturn election integrity laws. For example, in June of 2021, Biden's DOJ launched a lawsuit to overturn Georgia's law that requires a photo ID to vote, claiming this requirement somehow discriminates against black Americans.
- **No ID of any kind is required to vote in 22 states**, including battleground states of **Pennsylvania, Virginia, Minnesota, Nevada, Colorado**. A photo ID is required to vote in just 11 states.

Biden Drained the U.S. Strategic Petroleum Reserve to Help Democrats Perform Better in the 2022 Midterm Elections.

Biden drained the U.S. Petroleum Reserve by 40 % during the 2022 Midterm Election year in order to lower gas prices.

The Treasury Department estimates this did lower gas prices 40 cents on average nationally, which helped Democrats perform better than expected in the elections.

The U.S. Petroleum Reserve is intended to prevent the disruption of U.S. petroleum supplies during a national security crisis. It's not supposed to be used to gain political advantage in an Election Year.



Election Laws Broken by Democrats in the Key Battleground States in 2020

In Pennsylvania (a battleground state), the Democrat Governor, Democrat Attorney General, and Democrat Secretary of State, unilaterally, in violation of law, enacted numerous changes (all to help Democrats), including: the mass mail-out-ballot, the elimination of signature requirements, the elimination of postal markings to verify that ballots arrived in time, and extended the counting of mail-in-ballots for three days in violation of state law. The Pennsylvania Supreme Court later ruled that the mass mail-out ballot was unconstitutional under Pennsylvania law, but did not order a redo of the election.

In Michigan, the Democrat Secretary of State Jocelyn Benson unilaterally, without approval from the state legislature, mailed ballots to all 7 MILLION registered voters in this key battleground state. She also extended the date to accept ballots to November 14th, long after Election Day, November 2nd. A Democrat judge ordered that these ballots be accepted.

Wisconsin also had mass mail-in voting in 2020, with more than 1.4 MILLION ballots mailed out to voters. This was a 60 times increase over mail-in ballot requests in 2016. Furthermore, billionaire **Facebook founder Mark Zuckerberg** financed the placement of unmonitored ballot drop boxes in overwhelmingly Democrat urban areas in violation of state law. In addition, Zuckerberg-financed leftist non-profits instructed leftist precinct workers and prospective voters on how to bypass ballot security

measures. According to a report by the Public Interest Legal Foundation, Wisconsin lost track of more than 82,000 mail-in ballots.

In Georgia, the Secretary of State is a Republican. But in a lawsuit filed by Democrats, Georgia's Secretary of State **Brad Raffensperger**, as part of a settlement, agreed to extremely cumbersome signature verification requirements on mail-in ballots that make verifying signatures on ballots to confirm a voter's identity almost impossible. For example, if a signature on a ballot is found by an election official not to match the signature of the voter on file, the ballot and signatures would have to be reviewed by two other registrars. A majority of registrars would then have to agree that the signature is not valid; would have to sign the ballot envelope; and provide a written explanation for why a ballot is rejected. In practice, this made it nearly impossible to reject mail-in ballots. Georgia's legislature had no say in this settlement agreed to by Georgia's Secretary of State Brad Raffensperger

Biden Administration Works with Google and Big Tech to Rig Elections.

- In April of 2022, the Secretary of the U.S. Department of Homeland Security **Alejandro Mayorkas** announced the creation of a so-called "**Disinformation Governance Board.**" Its mission would be to work with Big Tech (Google, Facebook, Microsoft, Apple, Twitter, etc) to erase and shadow-ban conservatives from search engines and social media platforms and censor information that runs counter to the Democrats' political narrative.
- A partisan Democrat activist named **Nina Jankowicz** was appointed as Executive Director of this censorship agency. Her job was to determine what Americans could see, hear, and read. She labeled Republicans as "misinformers." This agency was established without legal authority, so was disbanded after pressure from Republicans. But the Biden Administration is using other means to target and erase conservatives from the internet and censor information unfavorable to the Democrat Party.
- Following Elon Musk's purchase of Twitter in 2022, Mr. Musk's team found that the FBI, the CIA, Democrat leaders in Congress, and the Biden Administration were working closely with the leadership of Twitter and Facebook to deplatform and "shadow ban" conservative accounts and suppress information favorable to conservatives. Thousands of prominent conservative influencers lost their accounts.
- During the lead-up to the 2020 Election, the FBI and CIA told Twitter, Google, Big Tech, and Big Media that the **Hunter Biden** laptop story was "Russian Disinformation" and false. The laptop computer that Hunter Biden abandoned at a computer store confirmed Joe Biden's business ties to China's regime and confirmed that Joe Biden was taking half of Hunter Biden's pay for Hunter's shady business dealings with China, Russia, Ukraine and other governments.
- A letter was signed by 51 intelligence community officials proclaiming the **Hunter Biden** laptop story was "Russian Disinformation" -- even though they knew at the time that the Hunter Biden laptop story was true. *The New York Post's* Twitter account was frozen by the old Twitter regime in response to the FBI's request. Big Tech and Big Media blocked distribution of the Hunter Biden story during the lead-up to the 2020 Election, which certainly had an impact on the 2020 Election favorable to Joe Biden.

100% Voting Rates in Nursing Homes in 2020

- 100 percent of registered voters cast ballots in at least 66 nursing homes in Wisconsin's heavily Democrat Milwaukee, Racine and Dane counties, according to findings by the Wisconsin Assembly Office Special Counsel (ASC). These include ballots cast by residents

who have been declared mentally incompetent to vote. These only include nursing homes the ASC was able to review by the time this report was issued.

- In another nine nursing homes in heavily Democrat Kenosha County, 97 percent cast ballots.
- In heavily Democrat Brown County, 95 percent of residents of 16 nursing homes cast ballots.

Joe Biden ended up winning Wisconsin by just 20,510 votes out of 3.2 million votes cast.

Billionaire Mark Zuckerberg Is Ramping Up His Meddling in Elections on Behalf of Democrats in 2024

Facebook founder **Mark Zuckerberg** (net worth \$125 BILLION) spent \$450 MILLION of his own money to tip the 2020 Election to **Joe Biden**. He did this primarily by asking Democrat election officials in Democrat areas if he (or the non-profits he funded) could put thousands of ballot drop boxes in overwhelmingly Democrat areas in battleground states – which he did. This one action certainly tipped the election to Joe Biden in **Wisconsin** – probably also in **Pennsylvania, Michigan, Georgia, and Arizona**. Donald Trump lost these states narrowly. He just needed 44,000 more votes to win Wisconsin, Georgia, and Arizona. Zuckerberg’s thousands of drop boxes in urban Democrat precincts likely made the difference.

While some states have passed laws banning the use of private money to fund these demographically biased ballot drop box placements, this is not stopping radical Left non-profits, such as the Center for Tech and Civic Life (CTCL) -- funded by Zuckerberg -- from attempting to replicate their 2020 strategy in 2024.

In 2022, Zuckerberg’s CTCL and other leftist groups launched the U.S. Alliance for Election Excellence, an \$80 million project seeking to “systematically influence every aspect of election administration.” According to CTCL, the group will train an army of election workers and officials to take Zuckerberg’s hijacking of 2020 elections to a new level in 2024.

Meanwhile, Zuckerberg’s **Facebook** and **Instagram** will continue to use algorithms to censor and suppress information favorable to conservatives throughout the 2024 Election season.

Democrat Money Laundering

Crypto fraudster **Sam Bankman-Fried** contributed \$10 MILLION to the Biden campaign in 2020 and \$40 MILLION to elect Democrats in the 2022 Midterm Elections. It was later discovered that SBF’s exchange FTX and Hedge Fund called Alameda Research were a Ponzi Scheme.

SBF’s mom, **Barbara Fried**, is a well-connected Democrat political operative. She co-founded a Political Action Committee called “Mind the Gap” in 2018 that has contributed more than \$140 MILLION to Democrat candidates. Barbara Fried is a law professor at Stanford University, as is SBF’s father Joseph Bankman, who served as an attorney for SBF’s business operations. The parents received a \$16.4 MILLION residence in the Bahamas from SBF and a \$10 MILLION gift. The father was also paid handsomely as an employee of FTX.

Noteworthy is the government of Ukraine used FTX to store its cryptocurrency and conduct crypto transactions. Many wonder how much U.S. taxpayer money went from Ukraine through SBF and into Democrat campaigns for the 2022 Midterm elections.

The Biden Justice Department Attempts to Steal Four House Seats in New York State

In 2014, New York state voters passed an amendment to the New York Constitution intended to ban gerrymandering. This is the unethical practice of the ruling party drawing Congressional districts in such a way, often in very odd shapes, to maximize the number of House seats controlled by the ruling party.

This amendment to New York's Constitution created an Independent Redistricting Commission to prohibit drawing maps "for the purpose of favoring or disfavoring incumbents or other particular candidates or political parties." (N.Y. Const. art. III, § 4(c)(5)).

The Biden Justice Department is now suing to have this amendment overturned so Democrats can redraw Congressional districts in such a way that will produce the theft of up to four House seats for Democrats.

How the Obama Administration Tried to Steal the 2016 Election. Then (When That Failed) Attempted a Coup Against President Trump.

- Starting in 2016, the **Obama CIA Director John Brennan**, **National Security Agency Director James Clapper**, and activist Democrat FBI agents, worked closely with the **Hillary Clinton** campaign to launch the "**Russia Collusion Hoax**" against candidate Donald Trump.
- This was an attempt by the Obama Administration to rig the 2016 Election by framing Donald Trump for colluding with Russia to steal the 2016 Election. This claim was later proven false by the two-year Mueller Investigation.
- The outgoing **Obama Administration** was able to trigger a Special Counsel investigation (the "**Mueller Probe**") of Donald Trump that lasted nearly two years. This investigation was staffed with 18 Democrat prosecutors and cost \$30 MILLION. The investigation came up with nothing on Donald Trump, but bogged down his Presidency for more than two years and helped Democrats in the 2018 midterm elections.
- The Mueller probe included the targeting of almost everyone close to Donald Trump. The home of Trump friend and political advisor **Roger Stone** was raided by an FBI SWAT team at 3 a.m. on January 25, 2019. Stone was prosecuted for not cooperating with the investigation.
- The Mueller probe targeted and bankrupted decorated soldier **Lt. General Michael Flynn**, apparently because General Flynn had the audacity to accept the position of National Security Advisor in the Trump White House.
- The Special Counsel prosecuted other members of Trump's inner circle on technical issues in a perfect example of **Stalin's** maxim for targeting political enemies: "**Show me the man and I will find the crime.**"
- Once the Mueller Investigation cleared Donald Trump of "Russia Collusion Hoax" claims, **Nancy Pelosi**, **Adam Schiff**, and their corrupt Democrat cronies in control of the House at that time launched two fraudulent Impeachments against President Trump.
- The 306-page report by Special Counsel **John Durham**, published in May of 2023, showed how the FBI was actively involved in promoting the lie that Trump colluded with Russia to win the 2016 Presidential Election. Durham found that the FBI opened its investigation into Trump without any

credible evidence. The FBI named its investigation of candidate Trump “Crossfire Hurricane,” a name which suggests what the FBI hoped to achieve. In its 2016 application to the Foreign Intelligence Surveillance Court (FISC) to begin surveillance of the Trump campaign, the FBI presented the infamous “Steele Dossier” to the secret court as its evidence, even though the FBI knew at the time that there was no truth to the lurid tales in this dossier about Trump; and despite knowing that this dossier was written by Hillary Clinton’s campaign.

- Needless to say, the Biden Department of Justice is not interested in prosecuting the many crimes by the Obama FBI detailed in the Durham Report. The Obama FBI and CIA attempted to tip the 2016 Election to Hillary Clinton by framing Donald Trump as an agent of Russia. But no one at the FBI or CIA has been prosecuted for this.

Biden’s Open Border – To Add Millions of New Voters for Democrats

The President of the United States has no more important duty than to defend America’s borders. Without a border we have no country.

As President, **Joe Biden** has refused to enforce U.S. immigration and border security laws. At the invitation of Joe Biden, more than 8 MILLION migrants have illegally poured across the border.

- Enact universal mass-vote-by-mail in every state to make Election fraud as easy as possible.
- Further extend “early voting” periods in every state (now 46 days in some states).
- **Allow illegal immigrants to vote.** Currently, the District of Columbia and municipalities in **California, Maryland, and Vermont** allow non-citizens to vote.
- Increase the number of Supreme Court Justices while Democrats are in power to pack the Supreme Court with a majority of radical Left Justices.
- End the Electoral College and change our national elections to a pure popular vote system, which would increase the power of big urban areas to the detriment of more rural “fly-over” country.
- **Split California** into three smaller Democrat-controlled states, which would add another four Democrats to the U.S. Senate.
